 With the support of grant funding two hyperbaric chambers were installed in our Wound Care Clinic. The HBO chambers offer pressurized oxygen therapy to heal wounds faster. • Achieved reaccreditation for Mammography by the FDA and State Inspection programs. Reaccreditation reflects the high quality of our equipment, and expertise of our staff and radiologists, as all three were evaluated and met stringent guidelines to receive reaccreditation.



Implemented Computerized Physician
Order Entry (CPOE). In September,
Hospitalist at Halifax Regional
Medical Center began utilizing a new
computerized system to help reduce
medical errors and significantly
improve patient safety. The CPOE
system allows orders to be integrated
with patient information, including
lab and prescription information. The
order is then automatically checked
for potential errors or problems which
keeps the safety of patients a top
priority.

- Implemented e-prescribing in the Emergency Care Center (ECC) where patient's prescriptions are sent electronically and conveniently to their pharmacy.
- Renovated 50% of patient's rooms on the 5th floor with new finishes and deep cleaning.
- To demonstrate our commitment to protect the safety and health of our patients, visitors, co-workers and our families, the Medical Center Volunteers agreed to mandatory flu vaccination as a condition of volunteering. They join the Board, physicians, and employees in this initiative.

The RV-CHI was established to help improve overall health of the Roanoke Valley through collective efforts of community organizations representing all aspects of the community. The CHI is a joint effort of area businesses, agencies and organizations to address family nutrition and physical activities to help raise awareness of the impact of less healthy life styles on the health of citizens in our community. The RV-CHI made its introduction to the community by hosting a community-wide FamilyFest expo on May 4, 2013.





## Financial Statement

In 2013, Halifax Regional experienced a 1.54% operating loss, or \$1,378,784. This follows 2011, in which the Medical Center generated a loss of \$265,838. In 2010, the profit was \$2.9 million. Healthcare reform and the declining reimbursements from Medicare and Medicaid make financial planning a challenge.

The primary reasons for the loss in 2013 were lower reimbursements, and an increase of \$11 million in bad debt and charity care from patients who did not pay for services and/or did not or could not pay their deductibles and coinsurance responsibilities. Charity care was \$9.9 million and bad debt was \$18,760,224. Other factors contributing to the higher expenses were the cost of providing physicians for the community.
